PRESIDENT'S MESSAGE Howard Frank

THE BEHAVIORAL ECOLOGY SYMPOSIUM REVITALIZED?

The 86th annual Florida Entomological Society meeting is coming up soon. FES has a great program planned that includes a Pioneer Lecture, three symposia, student competition, and a Wood-Destroying Insects Workshop. Each of these sections in the program should appeal to a variety of entomologists, from basic researchers to applied practioners, and everyone in between. I hope you are going to attend.

I'd like to focus specifically on the Behavioral Ecology Symposium, which is lacking this year. This particular symposium, which ran from 1978 to 2001 with a break of only one year (1987), has strengthened FES's reputation as a quality scientific society. We've had 23 symposia and 22 years of published papers (1,778 published pages) in the Florida Entomologist. It has been an outstanding accomplishment by the organizers to keep it going for so long, but some key folks have retired, and new blood and ideas are needed. I sense that the enthusiasm for continuing the symposium has diminished, and I want to strongly urge the membership to revitalize it and make it even stronger.

Here is a little history of the Behavioral Ecology Symposium. From 1978 to 2001, it was the only regular annual symposium of FES. It was initially given star billing and appeared right after the president's address on the first full day of our meeting. Eventually, a Pioneer Lecture (or an invited speaker) was placed after the president's address, and the symposium occurred after that event. Last year (2001), it slipped to the afternoon of the first full day of the meeting, and ran concurrently with another session. It is good to have additional symposia, but I fear the importance of the Behavioral Ecology Symposium has been lost.

The early days – A symposium called "Sociobiology of sex" was organized by Norm Leppla and Jim Lloyd, and was

presented at the 1978 annual meeting of the Southeastern Branch of the Entomological Society of America, in Gainesville. Some of the talks were published in Florida Entomologist 62: 1-34. However, not all speakers presented manuscripts for publication (which continues to be a concern for upcoming symposia). That symposium served as a model, and is here treated as the first of the series.

Jim Lloyd, aided and abetted by Tom Walker, was the organizer for the 1979 (Tallahassee), 1980 (Daytona Beach), 1981 (Daytona Beach), 1982 (Longboat Key), 1983 (Clearwater Beach), 1984 (Orlando) and 1985 (Ocho Rios, Jamaica) symposia at annual meetings of FES. These symposia lacked themes, but were well-attended. If you're interested in looking them up, manuscripts of some speakers were published in Florida Entomologist 63: 1-111, 64: 1-118, 65: 1-104, 66: 1-91, 67: 1-96, 68: 1-140, and 69: 46-130 and 728-754. Published editions of the 1978-1984 symposia were also printed separately, each with special covers, funded by the chairman of the Entomology and Nematology Department, University of Florida. These separate editions are becoming scarce, collector's items.

Earl McCoy and Don Strong organized the 9th Behavioral Ecology Symposium for the 1986 annual meeting, at Clearwater Beach, which had a theme: Colonization. Some manuscripts were published in Florida Entomologist 70: 1-48.

The intermediate days – Howard Frank and Earl McCoy also took up the challenge by organizing a 10th Behavioral Ecology Symposium at the 1988 annual meeting in Clearwater Beach, with the theme of insect parasitism. They repeated the event, with themes of predation (1989, Daytona Beach), defense (1990, Cancun, Quintana Roo, Mexico), immigration (1991, Naples), introduction (1992, Stuart), precinction (1993, Captiva Island), and exotica (1994, Stuart). Papers of some participants were published in Florida Entomologist 72: 1-64, 73: 1-110, 74: 1-59, 75: 1-83, 76: 1-113, 77: 1-84, and 78: 1-55.

Waldy Klassen organized the 17th symposium for the 1995 annual meeting in San José, Costa Rica. Manuscripts of

some participants are published in Florida Entomologist 79: 93-167.

The latter days. - John Sivinski, aided and abetted by Jim Lloyd, reorganized the symposium to occur, without theme, at annual meetings in 1996 (Clearwater Beach), 1997 (Daytona Beach), 1998 (Sanibel Island), 1999 (San Juan, Puerto Rico), 2000 (Naples), and 2001 (Stuart). Manuscripts provided by some participants appear in Florida Entomologist 80: 119-210, 81: 261-317, 82: 147-197, 83: 211-241, and 84: 552-601. Manuscripts of the 2001 (23rd, last) symposium have not yet been published.

Although not all presenters followed up with written publications, those that did increased the value of the Florida Entomologist. The average number of citations (extracted from the Science Citation Index database at the end of March 2003) for a published paper from it was 9.98 (1,368 citations for the 137 papers, including introductions to symposia). In contrast, all **other** parts of Florida Entomologist for the same years received 4,573 citations, and they included 1,149 papers (some of them organized into symposia) and hundreds of Scientific Notes as well as book reviews and other matter. So, the scientific merit exists to continue publishing the symposia presentations. Let's keep the tradition going, find some more energy and ideas for symposia topics, and forge on ahead.

EXECUTIVE COMMITTEE MEETING

MINUTES

Attendees: Ken Bloem (via conference call), John Capinera, Teresa DuChene, Howard Frank, Steve Lapointe (via conference call), Richard Mankin, Rob Meagher, David Oi, Stuart Reitz (via conference call), Lois Wood.

Business Manager Report (Teresa DuChene): The financial report is current through February 28, 2003: Morgan Stanley \$83,165.56, Bank of America \$19,314.98 for total assets of \$102,480.54.

We have seen a good start to 2003 as both full membership (185 vs. 213, respectively) and student membership (16 vs. 19, respectively) have increased from last years numbers. T. DuChene believed some of the increase was due to members requesting a hard copy of the Journal. However, library subscriptions were down from 167 last year to 83 this year. The sales tax exempt status will expire in a few months and T. DuChene has already called the State of Florida to obtain the necessary paperwork for renewal. T. DuChene has been working with R. Mankin toward the conversion of the present FE-5 database to a Microsoft Access database format. The Annual meeting is on schedule.

Computer Resources Committee (Richard Mankin): H. Frank released the email voting results of the Executive Committee to allow Tom Walker to proceed with putting *Florida Entomologist* on PubMed Central on the condition that the added expenditures not exceed \$50 per issue. The Executive Committee voted 7-1 in favor. E. O. Painter successfully formatted *Florida Entomologist* files and sent them to BioOne.

Program Committee (Richard Mankin): Four symposia are being organized by Steve Lapointe, Russ Mizell, Wayne Hunter, and Greg Wheeler. A wood-destroying organism workshop is also being organized. It was suggested to possibly include a fifth symposium focused on new products from the chemical industry.

Local Arrangements Committee (Steve Lapointe): Poster boards and digital projectors will be needed for the Annual meeting. We usually rent boards from a company near Tampa, but they must be transported to the meeting and returned. Digital projectors will be donated by USDA (Ft. Pierce, Gainesville, and Tallahassee) and the University of Florida (Entomology and Nematology Dept.).

Honors and Awards (Ken Bloem): The committee needs nominees for all awards by the June deadline. The Executive Committee recommended that a new award for a Regulatory Entomologist be announced and awarded. L. Wood will place an announcement in the next newsletter.

Newsletter (Lois Wood): The February/March newsletter is on the website and has been mailed. Items for the May/June should be sent to L. Wood or E. Buss by late April.

Education Committee (R. Mankin for Jim Price): Several volunteers provided excellent information to the public during the State Fair, although more volunteers will be needed for next year s Fair. USDA (Gainesville) will be sending 6 judges to the State Science Fair in Jacksonville in April. They will present the FES awards. The committee will provide additional certificates for deserving student presentations with an entomological theme.

Caribbean Conference (H. Frank): Venezuela has been eliminated as a possible meeting site. The committee will start to look at hotels in Miami or Miami Beach.

The next Executive Committee meeting is tentatively scheduled for May 20th.

PROGRAM HIGHLIGHTS

Four symposia topics have now been finalized. Russ Mizell is organizing a session on the Fall Armyworm, Stephen Lapointe on Entomological Outreach/Curriculum Development, Wayne Hunter on Applications of Genetics in Insect Physiological and Behavioral Research, and Greg Wheeler on Biological Control of Weeds.

The **Pioneer Lecture** honors Dr. Maurice Provost, a noted specialist in mosquito dispersal and longevity, ecology of tidelands, wildlife conservation and insect control strategies. In 1947 he accepted a full time position with the Florida State Board of Health as director of research on mosquito biology and control. He planned and organized the construction and staffing of the Florida Medical Entomology Laboratory at Vero Beach, and the development of Florida's medical entomological research program, and served as its only director since its founding in 1954. The Pioneer Lecture will be given by Dr. John Edman, Director of the Center for Vector Borne Diseases at the University of California Davis. He worked with Dr. Provost for 11 years at the Florida Medical Entomology Laboratory at Vero Beach.

A workshop on wood-destroying insects is being offered. The lecturers are: James Kimbrough (wood-destroying fungi); Rudi Scheffrahn (termites); Brian Cabrera (beetles); David Oi (ants and other wood-infesting hymenoptera); and, Bill Kern (marine borers, woodpeckers, other wood eaters). The cost is \$35. Seating is limited to 45. The session will run from 9am to 12pm, and participants can review material and ask questions between 12pm and 1pm. A box lunch is provided for those not attending the FES awards luncheon. Participants will earn 3 CEU's.
